

spray house plants. Remove pets and cover fish bowls before spraying. Do not allow children to contact treated areas until surfaces are thoroughly dry. **BROWN DOG TICKS:** Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

OUTDOOR USE: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills and runways. For control of wasps and hornets, apply after dark when all insects have returned to the nest. Repeat as necessary. Do not spray vegetation.

CAUTION: May be harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes, or clothing should also be avoided. Wash thoroughly after using. Avoid contamination of food, utensils, and food preparation areas. Do not use in commercial food preparation areas or in edible product areas of food processing plants. **DO NOT USE, POUR, SPILL OR STORE NEAR HEAT OR OPEN FLAME.** Do not smoke while spraying. Should illness occur, get prompt medical aid. To Physician—Atropine is antidotal. Do not reuse container. Bury or discard in a safe place.

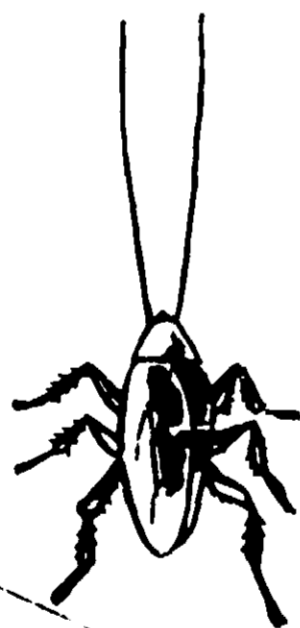

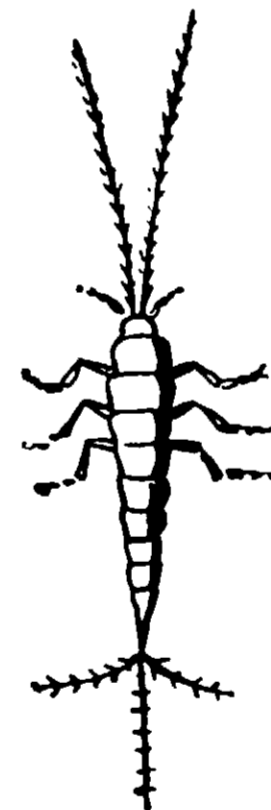

Direct spray away from people, plants and pets.

RESTRICTIONS: Do not apply to rugs, carpets, draperies, wallpaper, or similar materials that may be stained. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings. Do not allow the finger-operated, plastic sprayer to remain in McNess Bug Killer B solution for extended periods as the plastic sprayer may be damaged.

INDOOR USE IN HOMES: Spray into cracks, crevices, around baseboards and other places where insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves and in and around waste containers. For ants, spray trails and places where ants enter premises. Repeat as needed. Do not
