

**DIRECTIONS FOR CLEANING AND DEODORIZING
WHERE DISINFECTION IS NOT DESIRED**

FOR GENERAL CLEANING – Prepare one to fifty dilution (1 pint to 25 quarts water). Wash floors with this solution regularly. The addition of a small amount of Four-in-One to regular mopping water will aid materially in cleaning and deodorizing. This product will also aid in removing grease and odors from sinks, refrigerators and kitchen utensils. All treated food contact surfaces and/or equipment must be thoroughly scrubbed with detergent and rinsed with potable water prior to reuse.

AS A CLEANER AND DEODORIZER – For washing floors, woodwork, sinks, refrigerators, walls, basements, carpets and telephones, add 3–4 tablespoons of Four-in-One per gallon of regular scrubbing solution.

FOR SWEEPING – Prepare 1:120 dilution (1 oz. Four-in-One per gallon). Sprinkle over area to be swept. This will tend to keep down dust and leave a pleasant odor; or moisten sawdust or other sweeping material with this solution.
