GENERAL INFORMATION

MAGNOLIA SUPER-KILL is a specially formulated semi-soil sterilant for controlling a wide range of annual and perennial weeds and grasses. It is recommended for use only on non-cropland areas such as railroad rights-of-way, industrial sites, parking lots, power and telephone right-of-way, fence and foundation areas. The degree of control and duration of results will vary with the amount of MAGNOLIA SUPER-KILL applied, soil type, rainfall and other conditions. Highly recommended for municipal weed control and for barren soil.

Under Federal Insecticide,

To control most weeds and grasses on non-cropland areas such as railroad rights-of-way and industrial sites for an extended time, apply 5 gallons per acre of diluted MAGNOLIA SUPER-KILL after the most predominant weeds have been emerged. No agitation is required. MAGNOLIA SUPER-KILL should be applied with railroad on-track, truck mounted, or other standard spraying equipment. For treating small areas, a tank-type hand sprayer or sprinkling can may be used.

Users should consult experiment station or extension service weed specialists for recommendations as to use of MAGNOLIA SUPER-KILL in their particular area or contact MAGNOLIA service representative.
