

DIRECTIONS

FLIES: For use in & around buildings which house domestic animals, around yards and homes, use 31 oz. ECONO-CIDE per 2½ gal. of water. Apply at the rate of 1 gal. per 1,000 sq. ft. on painted surfaces where flies light or congregate. If fly population is severe increase dosage by 1/3.

Do not use in milk rooms. Avoid contamination of food. Remove all animals from buildings before treating. Do not use inside dwellings. Do not use where food products are handled.

ROACHES, ANTS, SPIDERS, SILVERFISH, CRICKETS: In and about homes use 25 oz. per gal. of water. Apply by means of a coarse spray or paint brush around window frames, baseboards, drainboards, under sinks, stoves, and to other areas frequented by insects. This water based spray may stain finished surfaces. Repeat as necessary. Do not contaminate food or utensils. **DO NOT USE IN FOOD PROCESSING PLANTS OR COMMERCIAL FOOD PREPARATION AREAS.**

MOSQUITOES AND SMALL FLYING INSECTS: Outdoors dilute 4 gal. ECONO-CIDE with 21 gal. water, fuel oil or diesel oil. Avoid applying oil based mixtures on valuable ornamentals as injury may occur. Spray or fog material over area to be treated.
