

# Cotton States 10% Heptachlor Granules

Cotton States 10% granular Heptachlor is for use in controlling soil insects attacking field corn and for use in control of many lawn insects such as ants, chinch bugs, chiggers and sod webworms. Use of this granular material greatly reduces the losses and hazards of contamination caused by the drift usually associated with dusts.

## DIRECTIONS FOR USE

**FOR USE ON HOME LAWNS**, for control of ants, fleas, ticks, chinch bugs, chiggers, white grubs, wireworms, cutworms, armyworms, sod webworms, June beetles and mole crickets use Cotton States 10% Heptachlor Granules at rate of 1 lb. per 2000 square feet. Immediately after treatment drench lawn by sprinkling. This deposits granules under blades of grass onto soil out of contact of pets and children. Do not allow children or pets to use area at any time during treatment and sprinkling. Do not use treated area until it is completely dry after sprinkling.

**FOR USE ON CORN** for control of southern rootworm and rough headed corn stalk beetle, apply Cotton States 10% Heptachlor Granules to partially prepared soil just prior to planting. Apply broadcast method or in drill. Immediately disc into upper 3 to 6 inches of soil. Use Cotton States 10% Heptachlor granules at rate of 20 lbs. per acre for southern corn rootworm and white grub control and 10 to 15 lbs. per acre for rough headed corn-stalk beetle. In most cases the above treatment will also control wireworms, and cutworms.
