STATEMENT OF PRACTICAL TREATMENT - 9 PT

Call a doctor (physician), Clinic or hospital immediately. Explain that the victim has been exposed to Methyl Parathion and describe his condition. If doctor cannot come, take victim to clinic or hospital. Move Victim immediately from the area where Parathion is present.

IF INHALED, remove victim to fresh air. If not breathing immediately give artificial respiration preferable mouth-to-mouth and maintain until doctor sees victim. If breathing is difficult give oxygen.

IF IN EYES, flush eyes with plenty of water for at least 15 minutes.

IF ON SKIN, remove victim from the vicinity of the Methyl Parathion; remove contaminated clothing and shoes and wash skin with soap and water.

IF SWALLOWED, induce vomiting immediately by giving two glasses of water and by touching back of throat with finger. DO NOT INDUCE VOMITING OR GIVE ANYTHING BY MOUTH TO AN UNCONCIOUS PERSON. Have victim lie down and keep quiet.
