It has been found highly effective against rabbit damage and moderately effective against deer damage. When properly applied, a single application has afforded protection for six months or longer under severe weather conditions.

DIRECTIONS FOR USE

This product should be diluted with an equal quantity of water before use. (Experience has proven that luke warm water is preferred for dilution of this product.) Stir or shake well before using. Application can be made by spraying or painting, although heavier coatings are obtained through spraying. For application to larger plantings, a good quality backpack sprayer is recommended. For a few trees, a fly sprayer or window-cleaning atomizer will suffice. Use sufficient repellent to obtain a uniform coating over portions of plants to be protected. Clean spray equipment with water as soon as possible after use. To permit repellent film to properly set up, application should be made under favorable drying conditions. (Apply when temperature is above 40° F and relative humidity is below 70%.) The snow depth should be considered when applying for winter use.
