IF IN EYES

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Hazards to Humans and Domestic Animals:

DANGER:

Corrosive. Causes irreversible eye damage. Harmful if swallowed, absorbed through skin or inhaled. Do not get in eyes or on clothing. Avoid working near high concentrations of spray mist/vapor. Use with adequate ventilation. Wash thoroughly after handling and before eating, drinking, chewing gum or using tobacco. Remove and wash contaminated clothing before reuse.

PERSONAL PROTECTIVE EQUIPMENT (PPE)

Wear long-sleeved shirt and long pants, chemical-resistant gloves made of any waterproof material, chemical-resistant aprons, chemical-resistant footwear and goggles or face shield when loading application equipment unless a closed loading system is used.

Promote[™] Hay Shield[®]* is a buffered propionic acid for use as a fungistat to reduce mold growth during storage. It can be used on alfalfa, bermuda grass, bluegrass, brome grass, clover, cowpea hay, fescue, lespedeza, lupines, orchard grass, peanut hay, peavine hay, rye grass, soybean hay, sudan grass, timothy and vetch. Treated hay may subsequently be used as an animal feed ingredient.

This product may only be used during the baling process if appropriate baler equipment is used which prevents exposure of non-target organisms to this pesticide product. Do not apply to pre-harvest hay and straw, cut hay and straw in the field prior to baling, or to hay and straw after it has been baled. Apply product to the hay and straw as it is fed into the baler, using the rates on this label. The baler application equipment must prevent drippage and drift, and must function properly and be used/maintained in accordance with the manufacturer's written operation instructions.

Application:

Use calibrated liquid metering applicator and appropriate equipment to ensurgenaximum distribution throughout the unprocessed hay at the time of baling.
