A dual-quat, no-rinse cleaner disinfectant, sanitizer and deodorant for general use in Schools, Institutions, Nursing Homes and Industrial Plants. Effective at 2 ounces per gallon against Staphylococcus aureus and Salmonella choleraesuis, as well as pathogenic fungi, Trichophyton interdigitale (athlete's foot fungi). Cleans efficiently through nonionic detergent action, and at the same time destroys odors. Used without final rinse as sanitizer at 200 ppm of quaternary on food contact surfaces. Phenol coefficient vs S. aureus, 30; vs S. typhosa, 19 (AOAC Method).

n-Alkyl (68% C 12 , 32% C 14 ) dimethyl

## DIRECTIONS

For cleaning, disinfecting, deodorizing and fungicidal activity, use 2 ounces per gallon (1:63) which provides 500 ppm quaternary. For pseudomonacidal activity, use 3 ounces per gallon (1:42). With cloth or mop, apply to floors, walls, wall tile, appliances, fixtures, showers, benches, diving boards, mats, toilet seats and other hard surfaces. For heavy soil, a precleaning step is recommended. For sanitizing non-food contact hard surfaces, use 1 ounce per gallon (1:127). For sanitizing food contact hard surface items, limit the level of quaternary to 200 ppm. using 2 ounces to 10 quarts water (1:159). No rinse required.



A cleaner disinfectant and sanitizer for use in Hospitals, Nursing Homes and Schools in reducing the hazard of crossinfection from environmental surfaces. Effective against Staphylococcus aureus, Salmonella choleraesuis and Pseudomonas aeruginosa, and against pathogenic fungi, Trichophyton interdigitale (athlete's foot fungi). Also virucidal, when used at 2 ozs. per gal. on environmental hard surfaces, against Influenza A2, Herpes Simplex, Adenovirus type 2, and Vaccinia. ## DIRECTIONS

Use at 2 ounces per gallon. With cloth or mop, apply to floors, walls, kitchen and lab equipment, garbage cans, toilet seats. urinals, showers, lockers and other hard surfaces. As sanitizer on food contact hard surface items, limit the level to 200 ppm of quaternary (2.8 ozs. per 5 gals) no rinse required. Pre-cleaning is recommended for heavy soil or organic matter
