Dilute with water and use either as a spray or a dip.

BACKRUBBER USE

1 gallon 10 gal, oil 1 pint 1/4 gal, oil

NOTE: Do not apply to dairy animals, or calves under 6 months of age.

Do not spray meat animals within 30 days of slaughter.

For controlling horn flies, on cattle; lice, mites (mange/scab mites) on cattle, hogs, sheep and goats; and ticks on cattle, sheep and goats.

SPRAYERS - High-pressure sprayers get better results when large numbers of animals are to be treated. Low-pressure sprayers and hand sprayers do the job for small groups of animals if the spray solution is mixed thoroughly before application.

IMPORTANT: Animals should be sprayed on a warm sunny day during the winter months. This makes it easier to complete the operation in time for the animals to dry before nightfall.

DIPPING VATS - Dipping vats are of great importance when large numbers of livestock are to be treated at one location. Dipping is the preferred method for mange or scabies where complete coverage of the animal is essential. Do not dip meat animals within 60 days of slaughter.

BACKRUBBER USE: For horn fly and lice control, dilute 1 gallon with 10 gallons fuel oil. Apply the diluted material to saturate the backrubber mechanism. Recharge the backrubber every 2 weeks or as necessary for control. Locate backrubber to give cattle or hogs free access to it. Best locations are usually watering places, salt licks, or feed racks.

Note: Do not allow calves under 6 months of age, or dairy animals to treat themselves. Do not permit meat animals access to this treatment within 30 days of slaughter.

DIRECTIONS FOR USE

FACE FLIES: For use against face flies one end of the backrubber must be low enough (not more than 15 to 20 inches above the ground to allow cattle to rub their faces and heads. The product is only effective for those cattle that rub the face and head. Dilute as for backrubber use.

HOGS: lice, sarcoptic mites -- A single application will usually give control. Do not treat sows within two weeks of farrowing nor for at least three weeks thereafter. Avoid treating animals in cold, stormy weather. Avoid treating overheated or sick animals. Pigs should not be sprayed when less than weaning age. Do not spray meat animals within 30 days of slaughter.

HORN FLIES, TICKS (such as cattle fever ticks, ear tick, Gulf coast tick, Lone Star tick and winter tick) and LICE: cattle, sheep and goats. Dip or spray. When dipping make sure the animal is held in the vat at least two minutes and submerge each animal twice during dipping. For sheep tick apply during warm weather soon after shearing or before the wool is 2 inches long. When spraying, use about 2 quarts per beef animal and proportionately less for smaller animals. If reinfestations occur repeat applications in 15 to 21 days or as needed for control. If calves are infested and must be treated, avoid dipping, apply spray sparingly. Do not add infested animals to the treated herd. Do not apply to dairy animals, or calves under 6 months of age. Do not apply to dairy goats. Do not spray meat animals within 30 days of slaughter.

SARCOPTIC MANGE: (cattle, sheep and goats) Dip or spray cattle, dip sheep and goats, for thorough animal coverage apply to herd when mange is found. If infestation is severe plan on a second treatment 15 to 21 days later. Do not apply to dairy animals or calves under 6 months of age. Do not spray meat animals within 30 days of slaughter.
