**STORAGE:** Store in a secure area, in original container only, away from fertilizer, food or feed.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Do not contaminate water, food, or feed by storage or disposal.

**CONTAINER DISPOSAL:** Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by incineration or, if allowed by state or local authorities, by burning. If burned, stay out of smoke.

The use of this product near feed, milk or uncovered milk utensils should be avoided to prevent contamination.

\* **FOR FOGGING** — Place cattle in barn and use approximately 1 ounce of LAND O LAKES HY-PY STOCK SPRAY for each 1,000 cubic feet of space. There are 16 fluid ounces in a pint. This will kill horse flies, stable flies, mosquitoes, and gnats in the barn and horn flies on cattle. Keep doors and windows closed 15 minutes. Sweep up and destroy all fallen insects. Follow the instructions of the manufacturer regarding the location of the fogging equipment in the barn to insure adequate coverage and optimum results.

\* **FOR SPRAYING** — When stable flies and horse flies become annoying to cattle, spray approximately 1 ounce of HY-PY STOCK SPRAY on each animal. Use only a spray gun which delivers a fine, light mist. For optimum kill and protection, give special attention to shoulders, belly and legs. Apply spray from a distance of 2 feet, permitting the spray particles to collect upon the hair. Wash teats and udders with an approved cleansing solution prior to milking.

For space spraying to kill flies, mosquitoes and gnats, close doors and windows and direct the spray toward the ceiling, making sure all areas are thoroughly sprayed. The room should remain closed for 15 minutes. Sweep up the fallen insects and destroy them. Repeat as necessary.

This spray will be more effective in fly control if breeding places such as manure piles, wet straw and hay accumulations are removed and screening of barns

is practiced.
