WEED CONTROL IN SEEDLING ALFALFA DURING ESTABLISHEMENT

Trust Herbicide may be applied as a prelant incorporated treatment for preemergence control of labeled weeds in direct seeded alfalfa. Apply and incorporate prior to planting according to product label directions.

Broadcast Application Rate:

Soil Texture	Trust Herbicide (pt/acre)
Coarse	1.0
Medium	1.0-1.5*
Fine	1.5

*Use Lower rate range in areas receiving less than 20 inches of rainfall and irrigation.

Precaution: Some crop stand reduction and stunting may occur with this use of Treflan HFP, however, reduced weed competition will allow establishment of quality stand.
