



UNICO Dairy and Stock Fly Spray

DIRECTIONS FOR USE

UNICO Dairy and Stock Fly Spray contains CIODRIN (R) Insecticide and VAPONA (R) Insecticide (DDVP) in a petroleum oil base. It is ready-to-use spray for application directly to lactating dairy cattle and beef cattle to control house flies, horn flies, stable flies, and mosquitoes, and to aid in control of face flies. Also may be used as a barn spray to control house flies.

DIRECT SPRAYING OF LIVESTOCK—Apply as a finely atomized mist uniformly distributed over each animal (dairy cattle and beef cattle) at a rate not to exceed 2 fluid ounces daily per animal. Use good spray equipment to spray each animal, preferably from the rear, directing the spray along both sides, including the belly, flanks, and withers, down each leg, over the back, and around the poll so that droplets are deposited on the face. Hold nozzle of sprayer 2 or 3 feet away from animal so as to deposit droplets on the hair. DO NOT WET THE HIDE. Repeat daily as needed. For milking dairy animals, apply the spray 20 to 30 minutes before beginning to milk, or after milking has been completed. DO NOT SPRAY UDDERS OF LACTATING DAIRY ANIMALS.

BARN SPRAYING—To control house flies in dairy barns, loafing sheds, livestock barns, and stables, apply 2 fluid ounces per 1,000 cubic feet as a finely atomized mist uniformly distributed throughout the area. To reduce air movement as much as possible, it is preferable to close windows and doors before spraying; leave them closed for 10 minutes after spraying and then ventilate the area. Repeat daily, morning and afternoon, as needed. Do not apply as a barn spray if animals which have received direct application within 8 hours remain in the barn; remove such animals before spraying.

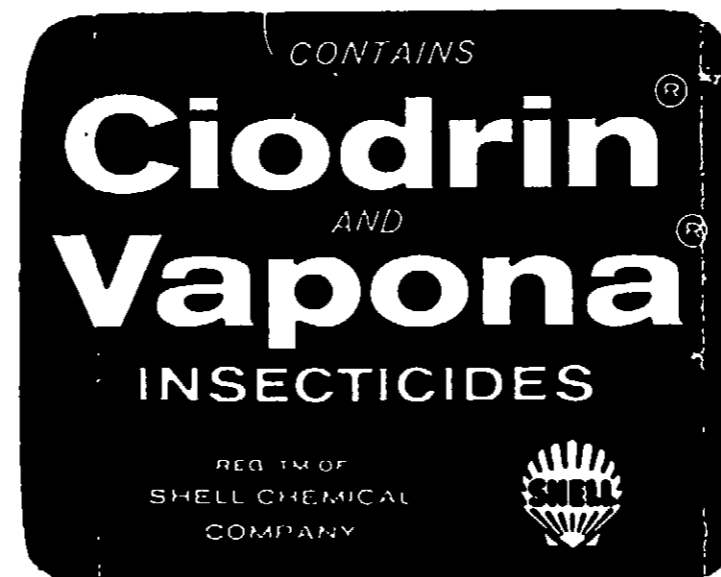

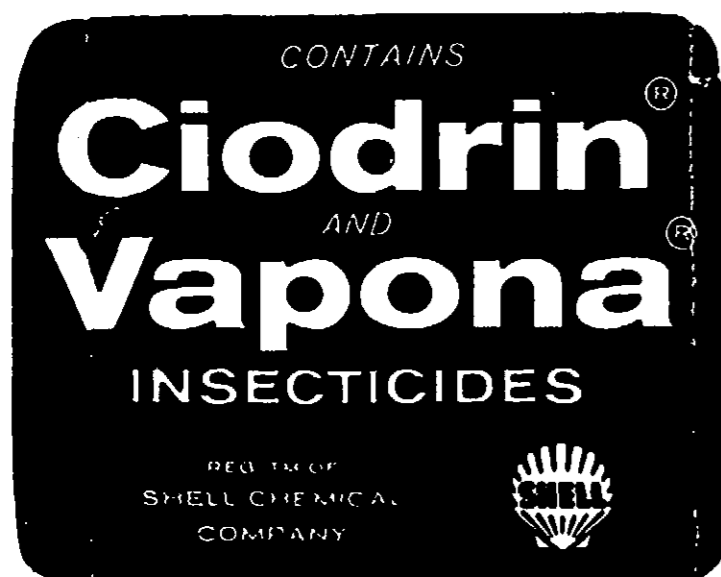

CAUTION
