

# UNICO Cygona Fiy Spray

#### DIRECTIONS FOR USE

RESIDUAL WALL SPRAY—For control of houseflies in dairy barns, hog pens, sheds, poultry houses and other farm buildings, mix 2 quarts of UNICO CYGONA FLY SPRAY in 12½ gallons of water. Apply this 1% spray to walls, ceilings and all fly-resting areas to the point of runoff. One gallon of spray will cover 500 to 1000 sq. ft. of surface. Repeat applications as necessary.

Remove animals from buildings prior to spraying.

SPOT SPRAY—Mix 1 pint of UNICO CYGONA FLY SPRAY in 2½ gallons of water and apply with knapsack or similar type sprayer to doorways, windows or other fly-resting areas. Repeat as necessary,

MAGGOT SPRAY—To control maggots in poultry droppings, caged layer houses, garbage piles and other breeding spots, mix 1 pint of UNICO CYGONA FLY SPRAY in 2½ gallons of water and apply as a coarse spray or with a sprinkling can. Repeat application as manure or garbage is added.

GENERAL OUTSIDE USE—To control houseflies around homes, recreational areas, garbage cans, animal quarters, food-processing plants, warehouses, loading docks and refuse areas, spray exposed areas such as wells, fences, and refuse containers with 1 pint of UNICO CYGONA FLY SPRAY in 3 gallons of water. Repeat treatment as necessary.

Do not contaminate food and feed products, drinking water, fountains, litter and feed troughs. Do not use in milk-processing rooms, including milk houses and milk storage rooms. Do not use in homes.
