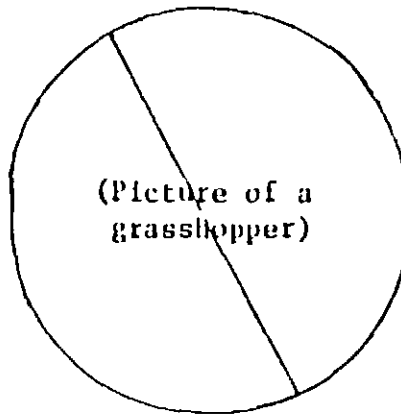

WARNING

Causes eye irritation. Harmful if swallowed. Do not take internally. May be absorbed through skin. May be injurious to the eyes and skin. Do not breathe vapors or spray mist. If Inhaled: Remove victim to fresh air. Apply respiration if indicated.

NOTE TO PHYSICIAN

Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds, and other wildlife. Do not apply directly to water. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes.

PESTS OF LAWNS AND OTHER ORNAMENTAL AND RECREATIONAL TURF GRASS AREAS: Use DURSBAN<sup>®</sup> LAWN AND ORNAMENTAL INSECT CONTROL to control the pests listed in the following table by application at the recommended dosages and in accordance with the directions given below. Dilute DURSBAN<sup>®</sup> LAWN AND ORNAMENTAL INSECT CONTROL with enough water to obtain complete and uniform coverage of pest infested areas and apply as a coarse (large droplets) spray using a low pressure sprayer such as a knapsack type, hose attached applicator or other

similar equipment. For best results, the lawn should be moist at the time of application and care should be taken to obtain complete and uniform coverage of pest infested areas.

Turfgrass (Hyperodes) weevil	3/4 Pint	Spray suspected problem areas in mid-April and again in mid-May or as recommended by your local Agricultural Exten- sion Service specialist in your area.
White grubs (European chafer and Japanese beetle larvae only)	3/4 to 1 1/2 Pints	For white grubs spray when grubs are young and actively feeding near the soil surface, usually during late July and August or as recommended by your local Agricultural Extension Service special- ist for your area. Immed- iately after spraying, irrigate the treated area with 1/2 to 1 inch of water to wash the insecti- cide into the underlying soil.
Bluegrass billbug	3/4 to 1 1/2 Pints	Spray early in the season when adults first appear. Retreat when needed.

PESTS OF ORNAMENTALS: Use DURSBAN<sup>®</sup> LAWN AND ORNAMENTAL INSECT CONTROL to treat flowers, shrubs, vines, shade and flowering trees, and evergreens found to be infested with pests listed in the following table. Dilute product with water according to directions given in the table and apply using suitable hand or power spray equipment in a manner to provide complete and uniform coverage. For best results apply a wetting spray to both upper and lower leaf surfaces and infested limb and trunk areas. Attempt to penetrate dense foliage but avoid overspraying to point of excessive runoff. Treat when pests appear and repeat at 7 to 10 day intervals, if needed. NOTE - DO NOT USE ON azaleas, camellias, poinsettias, rose bushes, or variegated ivy because of possible injury to these plants.

NOTE: Mosquitoes coming to rest on areas treated for control of turf and ornamental plant pests will be killed for varying periods of time after treatment, depending upon exposure of treated areas to weathering conditions.
