The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have not been reviewed or accepted by the Agency. 

WARNING

Do not apply this product in a way that will contact workers or other persons either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 12 hours.

COTTON: For Control of Early-Season Thrips and Cotton Fleahopper — Apply 8 to 15 pounds of Smith-Douglass Sevin 10% Dust per acre on appearance of insects.

For Control of Mid-and Late-Season Boll Weevil, Bollworm, Cotton Leaf Worm, Lygus and Stink Bugs and Cotton Leaf Perforator — Apply 10 to 20 lbs. of Smith-Douglass Sevin 10% Dust per acre at from five to seven day intervals on appearance of insects.

FOR CONTROL OF SALT-MARSH CATERPILLAR: Apply 23 pounds of Smith-Douglass Sevin 10% Dust per acre. APHID populations will be repressed when this insecticide is used in a regular schedule of treatments. Where mite infestations are encountered, use a recommended miticide. Sevin is believed compatible with all pesticides commonly used on cotton. Sevin may be applied after bolls open. Do not graze treated fields or feed trash to dairy or meat animals.

TOBACCO: Hand Dusting Applications for Budworms and Tobacco Flea Beetles, when hand dust applications are made on individual plants, apply 4 to 6 pounds per acre. Heavier applications may cause plant injury. Rotary dusters are recommended. Shaker cans and cloth bags usually result in excessive applications. Broadcast Application for Hornworms, Budworms, Japanese Beetles, Grasshoppers and Flea Beetles, apply 15 to 25 pounds per acre depending on size of the plants. Use the highest rate only on large plants. Full coverage is essential. Begin treatment when worms are small and repeat as needed. Heavier applications may cause plant injury.

NOTE:

- 1. If late applications are necessary, treat immediately after priming rather than before priming.**
- 2. Some phytotoxicity may occur on tender foliage in the presence of rain or high humidity of several days duration following application.**
