The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended, is acceptable provided that you make the labeling change indicated below before you release the product for shipment bearing the amended labeling:

Revise the Environmental Hazards section to:

This pesticide is toxic to birds, fish, and aquatic invertebrates. Birds feeding in treated areas may be killed. Clean up spilled product to reduce exposure to wildlife. Do not apply directly to water. Runoff may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwaters.

Submit five (5) copies of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records.

ORGANOPHOSPHATE**

If Swallowed: Call a physician or Poison Control Center immediately. Do not induce vomiting. Do not give anything by mouth to an unconscious person. **If On Skin:** Immediately wash skin with soap and water. **If In Eyes:** Flush eyes with plenty of water for 15 minutes. Get medical attention. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate degree of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as 2-PAM/protopam, may be therapeutic if used early; however, use only in conjunction with atropine. In case of severe acute poisoning, use antidotes immediately after establishing an open airway and respiration.

ENVIRONMENTAL HAZARDS

This pesticide is extremely toxic to fish, birds, and other wildlife. Do not apply directly to water. Drift and runoff from treated areas may be hazardous to aquatic organisms in adjacent aquatic sites. Do not contaminate water by cleaning of equipment or disposal of waste. Do not contaminate water when disposing of equipment washwaters.

Security Pro-Turf 1 Insect Control Granules will control Ants, Earwigs, Chinch Bugs, Fall Armyworms, Brown Dog Ticks, Cutworms, Mole Crickets, Sod Webworms, Leafhoppers, Spittlebugs, Chiggers, Clover Mites, Crickets, Fleas, Grasshoppers, and Ticks.

Apply Security Pro-Turf 1 Insect Control Granules to ornamental, recreational, and other turf grass areas uniformly using any hand or power operated gravity or rotary-type spreader designed for application of granular materials. Treat when insects first appear using this product at the rate of 2 1/2 pounds per 1,000 square feet. To help obtain uniform distribution, apply one half the required amount of product in one direction; then apply the balance at a right angle. Immediately after application, irrigate or sprinkle the turf with water so as to wash the granules into the zone of insect infestation. Consult the following table to determine the amounts of this product and water required. Retreat as necessary. Keep children and pets off treated areas until this material is washed into the soil and the turf is dry.
