DIRECTIONS

Description: A penetrating, water repellent fungicide for wood.

Product Use: Formulated especially for treatment of field crates-hampers, beverage boxes, pallets, and all wood containers for fruits and vegetables.

Preparation: For proper penetration, wood must be clean and dry (below 20% E.M.C.) and free from previous finish.

Application: Use at 60° or above. Immersion, brushing or flooding spray. Coverage varies according to the specie and condition of wood. Shook or assembled items can be treated. Immersion 15 seconds for shook, up to 3 minutes for thicker stock.

Lugs or Field Boxes, mixed hardwoods:

- 33" field box — 6-7 boxes per gal.
- 23½" tomato field box — 8-9 boxes per gal.
- 24½" vegetable field box — 6-7 boxes per gal.
- 26" special field box — 7½-8½ boxes per gal.
- 24" canners field box — 9½-10½ boxes per gal.

Bundles of KD ends and cleats, dipped for 1½ minutes, retain 16 gallons MBM. See data sheet for additional retention data.

Precautions: When treated wood will be used in conjunction with foodstuffs, growing plants, refrigerators, etc., user must be cautioned to allow wood to dry until all odor has disappeared (approximately 30 days) or until carrier has entirely evaporated to avoid possibility of contamination.
