USES

Premium Woodlife² VOCTN Wood Preservative is a clear, penetrating, water repellent and preservative for use on above ground exterior wood. Ideal for new wood or unfinished weathered wood. Protects and lengthens the life of millwork, wood shingles, siding, windo a, doors, structural lumber and fences. Provides excellent protection to wood when a clear, exterior natural finish is desared. Note: This product will not prevent natural graying of wood. With adequate retention, Premium Woodlife² VOCTN will protect wood against termites and wood destroying insects.

COVERAGE

100 to 150 sq. ft. per gallon with brush or roller applications.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Apply this product only as specified on this label.

Keep contents and freshly treated articles away from flame, food and living plants. Exposure to vapors can be harmful to plant life. All plants up to 30 feet away should be covered with a tarp or plastic sheet until application is completed. Keep solution and freshly treated wood away from plastics, asphalt shingles and tiles. Do not use on wood which will come in contact with food. This product must be applied out of doors to wood intended only for exterior use. Note: Keep container closed when not in use!

PHEPARATION

- 1. For best results, all cutting, gluing and sanding should be completed before applying Premium Woodlife? VOCTM. Wood must be clean and dry. Stains and paints should be stripped for best results. Do not use steel wool.
- 2. If mildew is present, remove by washing with Woodlif?

 Deck Cleaner & Brightener or a 50% dilution of household bleach and water. Rinse with water. If extractive bleeding has occurred, scrub with a diluted solution of oxalic acid (1/4 lb. per gallon of water) and then wash at once with clear water. Note: Read cautions on Bleach and Oxalic Acid labels before using.
- 3. Allow surface to dry before applying Premium Woodlife VCCTM.

APPLICATION

- 1. Minimum application temperature of 40°F (4.4°C)
- 2. Apply product with brush or roller. When roller coating, use a brush to finish edges and grooves. Do not spray.
- 3. Only one coat is necessary in most applications.
- 4. Two coats must be given to any wood that will be exposed to severe conditions of decay, staining, fungi or water (see Fungi listing below). Apply second coat while first coat is wet.
- 5. Fully saturate side and end grains to give maximum protection.
- 6. Do not puddle or build to wet film.
- 7. Not recommended for use on previously painted or stained wood.
- 8. Oil base paint or stain may be applied to Premium Woodlife VOC after at least 30 days. Latex based coatings are not recommended for use over Premium Woodlife VOC.

By following these application directions, effective control can be obtained against wood destroying decay fungi (like brown or white rot), staining fungi (like blue stain), surface mold (like black, brown or other colored mildew) and dimensional change.

DRYING TIME

Allow 24 to 48 hours drying time before using treated surface. Whit a minimum of 30 days before painting over Premium Woodlife VCC with an oil based coating. Latex coatings are not recommended for use over Premium Woodlife VCC.

THEMSING

Ready-to-use. No thinning required.

CLRAN IIP

Use DAPA Cleaner & Thinner or nonflammable solvent to remove wet Premium Woodlife VCCTM from all surfaces, brushes and rollers. Lacquer thinner may be used to remove dried product from glass and other surfaces.

STORAGE AND DISPOSAL

STORAGE: Store in original container in locked storage area. Do not store near heat or open flame. Keep contents away from food and feed.

HOUSEHOLD: Do not reuse empty container. Securely wrap empty container in several layers of newspaper and discard in trash.

COMMERCIAL

PESTICIDE DISPOSAL: Wastes resulting from use of this pesticide may be disposed of on site or at an approved waste disposal facility. Do not contaminate water, food, or feed by storage or disposal.
