**DIRECTIONS FOR USE**

**Initial Dose:** 1 gallon of this Algaecide to 50,000 gallons of water.

**Maintenance Dose:** 1 quart of this Algaecide to 50,000 gallons of water.

Initial dose is used when filling pool at beginning of swimming season. If pool has visible algae growth, treat with initial dose. Vacuum pool after 24 hours to remove algae debris. If visible algae are still present or reappear, repeat this treatment procedure as necessary. When pool is free of visible algae, use the recommended maintenance dose.

Maintenance dose should be added at 3-5 day intervals. If high temperatures prevail or pool has unusually heavy use, add maintenance dose more frequently.

If make-up water is added at the rate of more than 10% per week of pool capacity, add 1 quart of this Algaecide for each 10,000 gallons of fresh make-up water added per week. When swimming season is over, add 1 gallon of this Algaecide to 50,000 gallons of water in treating water left in pool. This dose helps provide a measure of control of algae growth during the winter months. This treatment will also help the servicing of the pool before it is returned to use the following season.
