DIRECTIONS FOR USE:

Spray infested surfaces until wet.

ROACHES, ANTS, SILVERFISH, SPIDERS, CRICKETS: Spray heavily into all cracks, around baseboards and other places where these insects hide. Also behind and beneath cabinets, refrigerators, sinks, stoves, etc. Spray other localized areas infested with these pests. Repeat treatment as required.

BROWN DOG TICKS: Thoroughly spray sleeping quarters of animals. Spray infested areas around baseboards, windows and door frames, wall coverings. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. **DO NOT TREAT ANIMALS WITH FORMULATION.**

FLIES, MOSQUITOES, WASPS AND FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

CARPET BEETLES: Spray edge under carpeting and rugs. Make to the floor and baseboards, cracks, closets and infested areas as necessary.

FLEAS, CHIGGERS, ANTS OUTDOORS: For removal of localized infestations of door areas, spray weeds and be around the home thoroughly. Avoid edible plants. Repeat applications as necessary and as reinfestations occur.

ANTS: Thoroughly spray sleeping areas. Spray infested areas around and door frames, wall coverings. Repeat as necessary. Fresh placed in animal quarters follow. NOT TREAT ANIMALS WITH

CARPET BEETLES: Spray edges of carpeting and under carpeting and rugs. Make localized application to the floor and baseboards. Spray directly into cracks, closets and infested areas of shelving. Repeat as necessary.

FLEAS, CHIGGERS, ANTS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas, spray weeds and bushy non-crop areas around the home thoroughly. Avoid spraying desirable plants. For ants thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.

DIRECTIONS FOR USE:
Dilute CHL-P-LIN 10% at rate of 1 part concentrate plus 99 parts of petroleum distillate for a .1% gamma spray for household use as a contact or space spray. In addition of 2% PERLIN 20 or other suitable insecticide agent must be added to obtain an effective space spray to control gnats, flies and mosquitoes. Apply to walls, ceilings, screens and other exposed surfaces. To paint around windows and door sills use a 0.5% gamma spray (1 plus 2% dilution).

FLIES AND MOSQUITOES AND GNATS: Use as a .1% spray (dilute 1 plus 99). Spray up the infested area, spray and allow to dry 10 minutes after treatment. Pick up the fallen insects and destroy them at the close of the 10 minute period.

CLOTHING: Use as a .1% spray (dilute 1 plus 99). Thoroughly all clothing to be protected, paying particular attention to seams and sides. Thoroughly spray all closets, trunks and other storage compartments. Repeat application every 30 days. Air thoroughly before wearing treated clothes.

BEDS: Use a .1% spray (dilute 1 plus 99). Thoroughly spray bed and mattress. Pay attention to crevices and hiding places about the hollows around baseboards. Wash and repeat application as necessary. Air thoroughly before sleeping in space.

SPIDERBITE AND SPIDERS: Spray on insects directly when possible or spray on their hiding places. Repeat application as necessary.

ANTS: Apply into cracks and other hiding places and hit nest directly with .1% spray. Use to treat ant trails and also apply to door sills and window frames, etc. Repeat application as necessary.

PRECAUTIONS: FUMES FROM VAPOR MAY BE IRRITANT TO EYES AND MUCOUS MEMBRANES. Avoid contact with skin and avoid inhalation and avoid contact with eyes. Prolonged contact with skin may cause irritation. Wash skin with soap and water for fifteen minutes if contact is allowed. Keep out of reach of children.
