We have received your revised amended registration form dated July 26, 1996, and found it acceptable.

The Agency has determined that the Confidential Statement of Formula (CSF), dated April 8, 1996, which was submitted with the above amendment in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. A copy of this CSF has been placed in our file for this product. All previous versions are obsolete.

If you want to switch to another source at a later date, you must satisfy the generic data requirements that were the basis of the original suspension and request an amendment, including a revised Confidential Statement of Formula (CSF), to make the change. Once the Agency has approved that amendment, you can ~~new~~ use the new source.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you make the following changes and submit one (1) copy to us before you ship your product:

- 1. Modify your ingredient statement as follows:

ACTIVE INGREDIENTS:	
Rotenone*	44.2%
Other Associated Resins	44.2%
INERT INGREDIENTS:	11.6%
TOTAL	100.0%

\*Nominal concentration. See certificate of analysis for actual rotenone content.

- 2. On the Front Panel, retain "DANGER-POISON".
- 3. Modify your PRACTICAL TREATMENT statement as follows:

FIRST AID

IF IN EYES: Flush with plenty of water for 15 minutes. Get medical attention if irritation persists.

IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

IF INHALED: Remove victim to fresh air. If not breathing give artificial respiration preferably mouth-to-mouth. Get medical attention.

- 4. Revise your "WARNING" statement as follows:

DANGER  
Fatal if swallowed. Avoid inhalation of dust. Harmful if inhaled or absorbed through skin. Avoid contact with skin.

- 5. Delete the "Physical Hazards" section since this product is not a liquid, the product that you repack does not have the statement, and you do have not a history of such a hazard with this product.

- 6. Revise your "Environmental Hazards" section as follows:

ENVIRONMENTAL HAZARDS

This product is extremely toxic to fish. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.

We are supplying a copy of this letter to Ms. Susan Jennings (703-308-8021), of our Special Review and Reregistration Division (SRRD), who prepared the basis of the original NOITS and to EPA Region 2. Any future letters about the NOITS to either RD or SRRD must include a copy to the other Division to insure good communications.
