TO KILL ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SCORPIONS: Spray into cracks, crevices around baseboards, and other places where these insects hide, Apply behind and beneath cabinets, refrigerators, sinks, stoves and in and around waste containers. Do not spray food-stuffs or Houseplants. Do not allow children to contact treated surfaces until surfaces are completely dry.

TO KILL BEDBUGS: Spray infested areas such as bedstead, springs, mattresses, and other parts of bedding that cannot be either laundered or dry cleaned only.

TO KILL FLEAS AND BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and where infestation occurs. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray pets with is formulation. Animals should be treated with **TOMIC CAT & DOG FLEA POWDER** or with a registered product for controlling fleas and ticks before reentering premises.
