DIRECTIONS FOR USE

THIS IS A CONTACT SPRAY

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

CONTACTING AS MANY PESTS AS POSSIBLE WHEN SPRAYING. ALL TREATMENTS SHOULD BE REPEATED AS NECESSARY.

GENERAL: IN THE HOME AND NON-FOOD AREAS OF INDUSTRIAL ESTABLISHMENTS: SPRAY SURFACES TO WETTING. POINT SPRAY AWAY FROM PEOPLE AND PETS. AVOID EXCESSIVE WETTING OF PLASTIC, RUBBER OR ASPHALT SURFACES, SUCH AS TILES AND FLOOR COVERINGS. DO APPLY ONTO RUGS, FABRIC, CARPETING OR FLOORING WITHOUT FIRST TESTING FOR STAINING OR OTHER ADVERSE RESULTS.

SCORPIONS AND EARNIGS-THOROUGHLY SPRAY AROUND DOORSILLS, WINDOW FRAMES OR OTHER AREAS WHERE THESE PESTS MAY ENTER THE

PREMISES. STORAGE AREAS AND OTHER SUCH HIDING PLACES SHOULD BE SPRAYED.

HOUSEFLIES, WASPS, MOSQUITOES-THOROUGHLY AND REPEATED SPRAYING OF SELECTED SURFACES SUCH AS DOORS, AROUND WINDOWS AND SCREENS, DOORSILLS AND SELECTED AREAS OF PORCHES WHERE INSECTS ALIGHT OR CONGREGATE, AND AREAS FREQUENTED BY THESE INSECTS, OF THIS CONTACT SPRAY.

SPACE SPRAY DIRECTION-FOR HOUSEFLIES, WASPS AND MOSQUITOES, CLOSE THE INFESTED AREA AND FILL IT WITH A MIST. IT SHOULD BE LEFT CLOSED FOR AT LEAST 10 MINUTES.
