# THIS 18 A CONTACT SPRAY.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SPACE SPRAY: For rapid control of Houseflies, Mosquitoes, Fruit Flies, Gnats, Small Flying Moths, Sand Flies, Wasps and Hornets: Close doors and windows and shut off ventilating systems. 
