### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**GENERAL:** This product must be applied using a compressed air sprayer. Do not apply this product using a trigger pump sprayer. Apply with low pressure spray equipment with a coarse spray nozzle. Spray until it is only until wet. Avoid excessive run-off. Apply to all insect breeding sites and harborage. Spray areas where these pests are found or hide. **DO NOT SPRAY** open floor areas, carpets, furniture, beds, or bedding. Repeat treatment as necessary.

### RESTRICTIONS

Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Do not use as a space spray. Provide adequate ventilation of areas being treated. Do not allow children to contact treated areas until surfaces are thoroughly dry. Do not store near feed, food, food products. Avoid contamination of feed, food, food processing equipment, and food handling surfaces.

Do not apply to animals. Remove pets and cover fish bowls before spraying. Do not spray plants.

### For Industrial and Institutional Use

Tomic Propoxur Residual Spray is a highly effective ready to use formulation for control of listed pests, including those resistant to certain chlorinated hydrocarbon and phosphate insecticides. This product drives insects from their hiding places, gives rapid kill and residual activity for up to 30 days.

**COCKROACHES** - Spray baseboards, cracks and crevices; around window and door frames; and under surfaces of shelves, drawers and work tables; behind and beneath cabinets, refrigerators, sinks and stoves; in and around waste containers, switch panels, junction boxes, floor drains and other places where cockroaches hide or nest. Pests flushed out of hiding should be sprayed directly.

**ANTS** - Treat ant trails, nests and points of entry such as windows and door sills.

**SILVERFISH, FIREBRATS AND PAPERLICE** - Spray areas where these pests are found or may hide, including dark corners of rooms, closets, cracks, crevices, along baseboards, and door sills and frames.

**BROWN DOG TICKS** - Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and where infestations occur. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. **DO NOT SPRAY ANIMALS WITH THIS FORMULATION.**

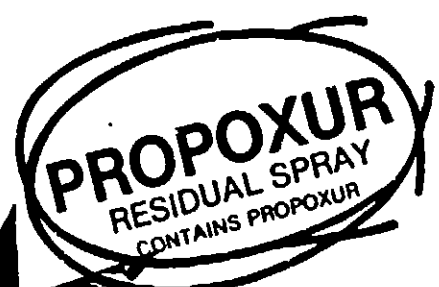
**CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES, CENTIPEDES, SOWBUGS, SCORPIONS, AND SPIDERS** - Spray into cracks, crevices, around baseboards, and other places where these insects hide. For Clover Mites give special attention around window frames.

**FLEAS, FLIES, GNATS, MOSQUITOES, PUNGS, AND SANDFLIES (OUTDOOR ONLY)** - Spray infested areas thoroughly, including outside surfaces of screens, window frames, foundations, patios and other areas where insects may enter. Do not spray vegetation.

### Insect Control in Research Facilities:

The use of Tomic Propoxur Residual Spray in and around animal quarters for insect control will not induce changes in liver microsomal enzyme activity in these animals.

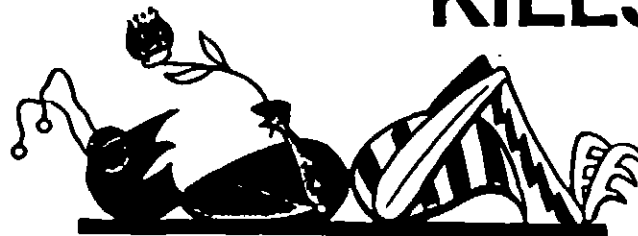
