DIRECTIONS FOR USE

Shake well before using: This product should be applied as a coarse (large droplet) spray infested surfaces until wet.

COCKROACHES, ANTS, SILVERFISH, SPIDERS, CRICKETS, EARWIGS: Spray areas where these pests are found or may hide, including dark corners of rooms, closets, cracks, crevices, along baseboards, door sills and frames, behind and beaneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installation.
