

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Shake well before using. This product should be applied as a coarse (large droplet) spray infested surfaces until wet.

Cockroaches, Ants, Silverfish, Spiders, Crickets, Earwigs: Spray areas where these pests are found or may hide, including dark corners of rooms, closets, cracks, crevices, along baseboards, door sills, and frames, behind and beneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installations. Pests flushed out of hiding should be sprayed directly. Spray ant trails, nests and points of entry. Do not spray open floor areas, carpets, furniture, or areas specifically directed on this label.

Brown Dog Ticks: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and where infestations occur. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. **DO NOT** spray animals with this formulation.

Fleas: Spray infested surfaces until wet, such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and where these insects appear. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area. **DO NOT TREAT PETS WITH THIS PRODUCT.** To control source of the flea infestation, pets inhabiting the treated premises should be treated with Tomic Dog and Flea Powder or a product registered for application to animals.

Flees and Mosquitoes: **USE ONLY ON OUTDOOR SURFACES.** Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Also spray dark corners and such as under eaves, porches, partitions, and in garages where these insects may congregate. Flees and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

Storage and Disposal: Do not contaminate, waste, food or feed by storage or disposal.

Pesticide Disposal: Pesticides, sprays, mixtures or rinses that cannot be used according to labeling instructions must be disposed of according to Federal, State or local procedures under the Resource Conservation and Recovery Act.
