WSCP 20 is used to control aloae, bacteria, and fund in recirculating comme, ..., and industrial water cooling towers and recirculating cooling systems. Prior to its use, systems must be cleaned to remove algal growth, microbiological slime, and other deposits. An initialuo addition of 2.9 to 7.3 fluid ounces of WSCP 20 per 1000 gallons of water to provide 24 to 60 ppm WSCP 20, based on the total weight of water in the system, is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 0.73 to 7.3 fluid ounces of WSCP 20 per 1000 gallons of water (6 to 60 ppm WSCP 20) every 2 to 5 days or as needed. The frequency of addition depends upon the relative amount of bleedoff and the seventy of the microbiological problem. Slug additions should be made in the sump of water cooling towers.

WSCP 20 is used to control bacteria in industrial air-washing systems that maintain effective mist eliminating commonents. Prior to its use systems should be cleaned to remove bacterial stime and other deposits. An initial stud case of 11.1 to 18.3 duid ounces of WSCP 20 Len 1000 gallons of water is recommended. Repeat initial desage until control is evident. Subsectiont after additions of 7.5 to 18.3 titled ounces of WSCP 20 per 1000 gallons of water should be employed each 1 to 5 days, or as needed. 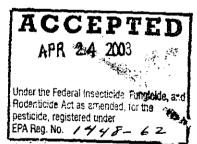
WSCP 20 is used to control the growth of algae swimming pools, exterior spas, whirtpools, hot tube, decorative foundains, and ponds that do not contain fish. For maximum effectiveness pools, spas, whirtpools , hot tubs, decorative fountains and points containing heavy growth of algae should be cleaned prior to using WSCP 20.

For pools having just visible algae prowth, add an initial dose of 37 to 56, fluid ounces of WSCP 20 per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool, add initially 20 to 37 fluid ounces of WSCP 20 per 10,000 gallons of water. Subsequent additions of 7 to 13 fluid ounces of WSCP 20 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance

Spas, whirlpools, hot tubs, decorative fountains, and ponds having just visible algae growth require an initial dose of 4 to 6 fluid ounces of WSCP 20 per 1000 gallons of water. For treatment of a freshly cleaned spas, whirlpools, hot tubs, decorative fountains, and ponds, add initially 2 to 4 fluid ounces of WSCP 20 per 1000 gallons of water. Subsequent additions of 1 to 2 fluid ounces WSCP 20 should be made every 5 to 7 days after the initial for maintenance

WSCP 20 will prevent growth of most algae during the off-season winter months when pools are not in use. For pools which have been properly treated, during the swimming season and are free of visible algae, add 20 to 32 fluid ounces of algaecide per 10,000 gallons of water. If, at the end of swimming season, pools have some visible algae growth, add 37 to 57 fluid ounces per 10,000 gallons of water. It is necessary that a uniform distribution of algaecide throughout the water and the pool be made for maximum effectiveness. If the pool is not covered, it may be necessary to repeat the treatment one or more times during the season.

WSCP 20 is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH, WSCP 20 can be used in pools and spas treated with chiorine chemicals and may reduce the amount of those chemicals normally required.
