b. The heading "Statement of Practical Treatment" must be changed to "First Aid" and the statements must be revised as follows:

IF IN EYES:

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control center or doctor for treatment advice.

IF SWALLOWED:

Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor.

IF ON SKIN:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment.

Do not discharge effluent containing these products into lakes, streams, ponds, oceans, or other waters unless in accordance with requirements of a National Pollutant Discharge Elimination System (NPDES) permit and permitting authority has veen notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage authority. For guidance contact your State Water Board or Regional Office U.S. Environmental Protection Agency".

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
