Conditions

Revise the label as follows:

1. Revise the statement "Slug additions should be made in the sump to control bacteria in industrial air-washing systems that maintain effective mist eliminating components." to read "Slug additions should be made in the sump of water cooling towers. W-60-7 is used to control bacteria in industrial air-washing systems that maintain effective mist eliminating components."



Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Directions for Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

W-60-7 is used to control the growth of algae in swimming pools, exterior spas, whirlpools, hot tubs, decorative fountains, and ponds that do not contain fish. For maximum effectiveness, pools, spas, whirlpools, hot tubs, decorative fountains, and ponds containing heavy growth of algae should be cleaned prior to using W-60-7.

For pools having just visible algae growth, add an initial dose of 11 - 17 fl oz of W-60-7 per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool, add initially 6 - 11 fl oz of W-60-7 per 10,000 gal of water. Subsequent additions of 2 - 4 fl oz of W-60-7 per 10,000 gal of water should be made every 5 - 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, decorative fountains, and ponds having just visible algae growth require an initial dose of 1 - 2 fl oz of W-60-7 per 1000 gal of water. For treatment of a freshly cleaned spa, whirlpool, hot tub, decorative fountain, or pond, add initially 0.6 - 1.1 fl oz of W-60-7 per 1000 gal of water. Subsequent additions of 0.2 - 0.4 fl oz of W-60-7 should be made every 5 - 7 days after initial treatment for maintenance.

W-60-7 will prevent growth of most algae during the off-season winter months when pools are not in use. For pools, which have been properly treated during the swimming season and are free of visible algae, add 6 - 10 fl oz of algaecide per 10,000 gal of water. If, at the end of swimming season, pools have some visible algae growth, add 12 - 17 fl oz per 10,000 gal. It is necessary that a uniform distribution of algaecide throughout the water and the pool be made for maximum effectiveness. If pool is not covered, it may be necessary to repeat the treatment one or more times during the season.

W-60-7 is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. W-60-7 can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix W-60-7 with concentrated dry or liquid chlorine products.

W-60-7 is used to control algae, bacteria, and fungi in recirculating commercial and industrial water cooling towers. Prior to its use, systems must be cleaned to remove algal growth, microbiological slime, and other deposits. An initial slug addition of 0.9 to 2.2 fluid ounces of W-60-7 per 1000 gal of water to provide a concentration of 8 to 20 ppm of W-60-7 based on the total weight of water in the system is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 0.2 to 2.2 fluid ounces of W-60-7 per 1000 gal of water (2 -20 ppm W-60-7) should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump to control bacteria in industrial air-washing systems that maintain effective mist eliminating components. Prior to its use, systems should be cleaned to remove bacterial slime and other deposits. An initial slug dose of 3.33 - 5.55 fluid ounces of W-60-7 per 1000 gal of water is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.25 - 5.55 fluid ounces of W-60-7 per 1000 gal of water should be employed each 1 - 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the bacterial problem. Slug additions may be made to the sump or to the water collection trays of the airwash system.
