On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

Based on your response to the Potassium N-methyldithiocarbamate RED, the EPA has reregistered this product subject to the comments recorded in the succeeding paragraph. This action is taken under the authority of section 4(g) (2) of the Federal Insecticide, Fungicide and Rodenticide Acts, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. The EPA may require submission of data at any time to maintain the registration of the subject product.

b. Include additional text to the Note to Physician that addresses eye irritation concerns.

c. Per the acute toxicity review, the Hazards to Humans and Domestic Animals must be revised to read:

"DANGER

Corrosive. Causes irreversible eye damage and skin burns. Do not get in eyes, on skin, or on clothing. Harmful if swallowed. Harmful if absorbed through skin. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wear goggles or face shield, coveralls over long-sleeved shirt and long pants, socks, chemical-resistant footwear, chemical-resistant gloves made of any waterproof material, and a chemical-resistant apron when cleaning equipment.

d. Add the following User Safety Requirements text to the label:

"Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry.

Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them."

e. Per the acute toxicity review, the following User Safety Recommendations must be added to the label:

"User Safety Recommendations

User must wash hands before, eating, drinking, chewing gum, using tobacco, or using the toilet.

Remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.

Remove PPE immediately after handling this product. As soon as possible, wash thoroughly and change into clean clothing."

f. The first sentence of the Environmental Hazard statement must be revised per the RED to read "this pesticide is toxic to mammals, birds, aquatic invertebrates and fish."

g. Per Page 201 of the RED, the text "a metering pump system must be used when applying this product" must be added to the label.



Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for the later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

(Liquid residue removal statement for nonrefillable containers with capacity of >5 gals)

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

(Text for all nonrefillable containers)

Then offer for recycling if available or reconditioning, if appropriate, or puncture and dispose of in a sanitary landfill, or, if allowed by state and local authorities by burning. If burned, stay out of smoke.

(Text for refillable containers)

Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller.

For containers larger than 55 gallons:

To clean the container prior to refilling or disposal, use a pressure wash as follows: Empty the remaining contents into application equipment or a mix tank. Use a pressure wash system that rinses all interior sides with water and that is rated at >40 psi and >120F. Pressure wash the container for a length of time that ensures that a minimum 25% of the container volume of water is used. During the pressure wash, ensure that the container valve is left open for continuous draining. Collect the rinsate and empty into application equipment or a mix tank or store rinsate for later use or disposal. Allow container to drain for 10 minutes after pressure wash is completed.

For containers 55 gallons and smaller:

To clean the container prior to refilling or disposal, use a triple rinse wash as follows: Empty the remaining contents from this container into application equipment or a mix tank. Fill the container about 10 percent full with water. Agitate vigorously. Pour or pump rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this rinsing procedure two more times.

Do not discharge rinsate containing this product unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge rinsate containing this product to sewer systems without prior approval from the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.

Directions for Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

COOLING WATER SYSTEMS: NM-875-11 is used to inhibit the growth of microorganisms in industrial, commercial and institutional cooling water systems. In noticeably fouled systems, NM-875-11 should be added at a rate of 6.9 to 13.9 fl. oz. of NM-875-11 per 1000 gallons of system water (56-115 ppm) until control is evident. Subsequent additions of NM-875-11 should be made to the system as needed at a rate of 2.3 to 13.9 fl. oz. of NM-875-11 per 1000 gallons of system water (20-115 ppm) to maintain control. The frequency of treatment depends upon the severity of the microbiological problem. For best results the system should be cleaned prior to treatment. **Not for use in once-through cooling systems.**

INDUSTRIAL WATER PURIFICATION SYSTEMS: NM-875-11 is used to control microbiological fouling in industrial water purification systems including reverse osmosis systems, filters, clarifiers, and ion exchange equipment. For off-line treatment, NM-875-11 should be fed at a concentration of 24.5 to 49.0 fl. oz. per 1,000 gallons of water (200-400 ppm) for 4 to 8 hours. For on-line maintenance treatment, dosing of 4.9 to 9.8 fl. oz. NM-875-11 per 1,000 gallons of water (40-80 ppm) for 6 to 12 hours should be made once a week or as needed to maintain control. **Not intended for use in potable water systems. Not registered for this use in California.**
