### DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

NM-875-7 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.9 NM-875-7 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 NM-875-7 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.

Disodium cyanodithioimidocarbonate ..... 3.68 %

Potassium N-methyldithiocarbamate ..... 5.07 %

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS
