DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

NM-35-3 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 1.5 NM-35-3 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 0.5 NM-35-3 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in a cool, dry place. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a sanitary manner. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. The use of excess pesticide, spray mixture, or rinsate is a violation of Federal law.
