

NM-35-1 \_\_\_\_\_ is used in recirculating commercial and industrial water systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 1.5 NM-35-1 \_\_\_\_\_ per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 0.5 NM-35-1 \_\_\_\_\_ per 1000 gallons

every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage. **STORAGE:** Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
