## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive. Causes irreversible eye damage and skin burns. Harmful if absorbed through skin or inhaled. Do not get in eyes, on skin or on clothing. Wear goggles or faceshield and rubber gloves and protective clothing. Harmful or fatal if swallowed. Avoid contamination of food. Wash thoroughly after handling and before eating, drinking or using tobacco. Remove contaminated clothes and wash before reuse.

STATEMENT OF PRACTICAL TREATMENT: In case of skin contact, wash with plenty of soap and water. Remove contaminated clothing and wash before reuse. #### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Do not stack more than five drums high. Drums should be opened in well-ventilated areas. Leaking or damaged drums should be placed in overpack drum for disposal. Splits should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use.

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

COOLING WATER SYSTEMS: NM-35-1 is used to inhibit the growth of microorganisms in industrial, commercial and institutional cooling water systems. In noticeably fouled systems, NM-35-1 should be added at a rate of 1.5 to 3.0 fl. oz. of NM-35-1 per 1000 gallons of system water (15-30 ppm) until control is evident. Subsequent additions of NM-35-1 should be made to the system as needed at a rate of 0.5 to 3.0 fl. oz. of NM-35-1 per 1000 gallons of system water (5-30 ppm) to maintain control. The frequency of treatment depends upon the severity of the microbiological problem. For best results the system should be cleaned prior to treatment.

INDUSTRIAL WATER PURIFICATION SYSTEMS: NM-35-1 is used to control microbiological fouling in industrial water purification systems including reverse camosis systems, filters, clariflers, and ion exchange equipment. For off-line treatment, NM-35-1 should be fed at a concentration of 5.0 to 10.0 ft, oz. per 1,000 gallons of water (30-100 ppm) for 4 to 8 hours. For online maintenance treatment, dosing of 1.0 to 2.0 ft, oz. NM-35-1 per 1,000 gallons of water (10-20 ppm) for 6 to 12 hours should be made once a week or as needed to maintain control. Not intended for use in potable water systems.
