**DANGER:** Corrosive, causes irreversible eye damage and causes skin damage. Harmful or fatal if swallowed or absorbed through the skin. This product is a potential skin sensitizer. Workmen handling this product or treated material should wear impervious gloves, goggles or face shield, and protective clothing.
