DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with the labeling.

COOLING TOWERS: T-30-2
Prevent rot and internal staining of cooling tower wood against soft or surface rot and internal staining or painting a dispersion containing 0.5 to 0.7% T-30-2 in water onto the clean wood surfaces. The amount applied should be _____ per 1000 ft.² of surface.

Rot can also be inhibited by periodic shock doses of T-30-2 to the recirculating cooling water at the tower basin or collection tank. A bleedoff should be stopped for 4 to 6 hr. after treatment. Repeat every four months.

COOLING WATER: T-30-2
To inhibit bacterial and fungal degradation of cooling water, begin, the system should be cleaned thoroughly to remove biological slime, and other deposits. System should then be treated with an initial dose of 0.6 to 3.7 fl. oz. of T-30-2 per 1000 gal. water in the system. Subsequent bleedoff should be made every 1 to 5 days, depending on the amount and severity of microbiological fouling.

DRINKING FLUIDS: To inhibit bacterial and fungal degradation of drinking water, add T-30-2 at concentrations of 0.05 to 0.25% based on the total wet weight of the water.

PETROLEUM SECONDARY RECOVERY: T-30-2
To inhibit bacterial and fungal degradation of water-based and water-soluble or emulsifiable concentrates, add T-30-2 to the water before or after injection pumps and injection well headers. Control is noticeably fouled, add 0.6 to 3.7 fl. oz. of T-30-2 per 1000 gal. of water.

WATER TREATMENT: T-30-2
To inhibit bacterial and fungal degradation of water-based and water-soluble or emulsifiable concentrates, add T-30-2 to the water before or after injection pumps and injection well headers. Control is noticeably fouled, add 0.6 to 3.7 fl. oz. of T-30-2 per 1000 gal. of water.

CUTTING FLUIDS: T-30-2
To inhibit bacterial and fungal degradation of water-based and water-soluble or emulsifiable concentrates, add T-30-2 to the cutting fluid before or after injection pumps and injection well headers. Control is noticeably fouled, add 0.6 to 3.7 fl. oz. of T-30-2 per 1000 gal. of water.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **PESTICIDE STORAGE:** Do not expose to extreme temperatures. High drums should be opened in well ventilated areas. Leaking drums should be opened in well ventilated areas. Spills should be absorbed in a sanitary landfill.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. If you cannot dispose of this pesticide, spray mixture, or residue in a sanitary landfill. If by use according to label instructions, contact your State Pesticide Control Agency or the Hazardous Waste representative at your EPA Regional Office. **CONTAINER DISPOSAL:** Triple rinse (or equivalent). Then off-pump and dispose of in a sanitary landfill, or by other procedures approved by local authorities.
