HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive. Causes irreversible eye damage. Causes skin damage. This product may cause allergic skin reactions. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed.

FIRST AID: *If in eyes,* flush with plenty of water. Get medical attention. *If on skin,* wash with plenty of soap and water. wood against soft or surface rot and internal or dry rot. Use a solution containing 3.0 to 4.2% T-5-1 on all wood surfaces. The amount applied should provide 3.6 to 4.8 fl oz per 1000 ft² of wood surface. Soft or surface rot can be controlled by T-5-1 to the recirculating

DRILLING FLUIDS: To inhibit bacterial and fungal degradation of wells, T-5-1 is used at concentrations of 0.3 to 1.5% based on the total wet weight of the fluid.
