

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with labeling.

B-103-3 is used to inhibit bacterial degradation of water-based and emulsifiable cutting fluids and metalworking operations. It is used as a diluted cutting fluid at a rate of 150 to 250 parts per million B-103-3 after final dilution with water to prevent growth on the inside walls of fluid storage tanks, higher concentrations are needed. For this application, that B-103-3 be added to the cutting fluid as prepared to provide a concentration of 150 to 250 parts per million.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **PESTICIDE STORAGE** Do not expose to extreme low temperatures. Drums should be opened in well ventilated areas and stored upright for disposal. Spills should be absorbed with an appropriate material.

PESTICIDE DISPOSAL Pesticide wastes are acutely toxic. Do not discharge into the environment. Do not use according to label instructions contact your State or the Hazardous Waste representative of your EPA Region. **CONTAINER DISPOSAL** Triple rinse (or equivalent) and dispose of in a sanitary landfill, or by other means.
