It is a violation of Federal law to use this product in labeling.

B-30-5 is used to inhibit bacterial degradation of water-based and water emulsifiable cutting fluids and coolants in metalworking operations. It should be used as a diluted cutting fluid at a rate of 150 to 250 parts per million B-30-5 after final dilution with water. Higher concentrations are needed. For this application, that B-30-5 be added to the as prepared to provide a concentration of _____ parts per million.

STORAGE & DISPOSAL
