

diluted cutting fluid at a rate of 150 to 250 parts per million B-30-4
after final dilution with water to prevent
growth on the inside walls of
fluid storage tanks, higher concentrations
are needed. For this application
that B-30-4 be added to the
as prepared to provide a concentration of
parts per million.
