

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

B-30-2 is used to inhibit bacterial and fungal degradation of water-based and water-soluble or emulsifiable cutting fluids and coolants used in metalworking operations. It should be added to the diluted cutting fluid at a rate that will provide 150 to 250 parts per million B-30-2 (weight/weight) after final dilution with water. To prevent fungal growth on the inside walls of the diluted metalworking fluid storage tanks, higher concentrations of B-30-2 are needed. For this application, it is recommended that B-30-2 be added to the diluted cutting fluid as prepared to provide a concentration of 1000 to 1250 parts per million.


