DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

B-30-1 is used to inhibit bacterial and fungal degradation of water-based and water-soluble or emulsifiable cutting fluids and coolants used in metalworking operations. It should be added to the diluted cutting fluid at a rate that will provide 150 to 250 parts per million B-30-1 (weight/weight) after final dilution with water. To prevent fungal growth on the inside walls of the diluted metalworking fluid storage tanks, higher concentrations of B-30-1 are needed. For this application, it is recommended that B-30-1 be added to the diluted cutting fluid as prepared to provide a concentration of 1000 to 1250 parts per million.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
PESTICIDE STORAGE: Do not expose to extreme temperatures. Do not stack more than five drums high. Drums should be opened in well ventilated areas. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill.


