Subsequent slug additions of 1.1 to 6.6 fluid ounces of NM-175-1 per 1000 gallons of water should be employed every 1 to 5 days as needed. The frequency of addition depends upon the relative amount of bleedoff and the serverity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.
