DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

D-10-5 is used in industrial and/or commercial recirculating cooling tower systems and industrial air-washing systems to control microbiological slime. Prior to the use of D-10-5 in industrial and/or commercial recirculating cooling tower systems, systems should be cleaned to remove algal growth, microbiological slime, and other deposits. Then make an initial slug addition of 12.0 to 17.9 fl. oz. of D-10-5 per 1000 gal. of water to provide 100 to 150 ppm of D-10-5 based on total weight of water in the system. Repeat initial dosage until control is evident. Make subsequent slug addition of 6.0 to 17.9 fl. oz. of D-10-5 per 1000 gal. of water (50 to 150 ppm D-10-5) every 2 to 5 days or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of recirculating cooling tower systems.

D-10-5 is used in industrial air-washing systems which maintain effective mist-eliminating components. Prior to its use, systems should be cleaned to remove bacterial slime and other deposits. An initial slug dose of 28.1 to 35.9 fl. oz. of D-10-5 per 1000 gal. of water is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 21.0 to 35.9 fl. oz. of D-10-5 per 1000 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the bacterial problem. Slug additions may be made to the sump or the water collection trays of the airwash system.

D-10-5 is used to control sulfate-reducing bacteria in petroleum secondary-recovery waterflooding operations. In systems fouled with microbiological deposits, D-10-5 should be added as a slug dose to provide a concentration of 40 to 80 ppm (5.0 to 10.0 fl. oz. of D-10-5 per 1000 gal. of water treated). This should be followed by a continuous addition of D-10-5 employing chemical-metering pump to maintain a concentration of 40 ppm, based on total weight of water treated. Both slug additions and continuous addition of D-10-5 should be made at the heater-treat dump, gathering lines, or receiving tanks. Addition should always be made upstream of the filter.

D-10-5 is also used to inhibit the growth of fungi and bacteria in water-based drilling muds, completion fluids, packer fluids, and other water-based drilling fluids containing starch, gums, sugars, or other organic materials. For these purposes D-10-5 is added at rates of 15 to 25 gal. per 100 barrels of fluid (0.36 to 0.60% by volume).

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Do not stack more than four drums high. Leaking or damaged drums should be placed in overpack drums for disposal. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Keep container closed when not in use.



D-10-5 is used in industrial cooling tower systems and industrial air-washing systems. Prior to the use of D-10-5 recirculating cooling tower systems, systems should be cleaned to remove microbiological slime, and other deposits. Then make a

17.9 fl. oz. of D-10-5 per 100 to 150 ppm of D-10-5 of water in the system. Repeat initial dosage until control of addition of 6.0 to 17.9 fl. oz. of D-10-5 gal. of water to 50 to 150 ppm D-10-5 days or as needed. The frequency of addition depends on bleedoff and the severity of the microbiological problem in the sump of recirculating cooling tower systems.

D-10-5 is used in industrial water systems to maintain effective mist-eliminating components. Periodically clean to remove bacterial slime and other deposits.

35.9 fl. oz. of D-10-5 per 1000 gal. of water is recommended. Repeat initial dosage until control is evident. 21.0 to 35.9 fl. oz. of D-10-5

water should be employed every 1 to 5 days, or as often as depends upon the relative amount of bleedoff and severity of the problem. Additional dosages may be made to the sump or the water column.

D-10-5 is used to clean petroleum secondary-recovery waterfloods of microbiological deposits. D-10-5

is added at a dose to provide a concentration of 40 to 80 oz. of D-10-5 per 1000 gal. of water followed by a continuous addition of D-10-5 per 1000 gal. of water. A chemical-metering pump to maintain a constant weight of water treated. Both slug additions and continuous additions are acceptable.

D-10-5 is used to clean dump, gathering lines, or receiving tanks. Addition of D-10-5 to the filter.

D-10-5 is also used to clean bacteria in water-based drilling fluids, completion fluids, and based drilling fluids containing starch, gums, sugars, or other additives. D-10-5 is added at a rate of 0.36 to 0.60 gal. per 100 barrels of fluid.
