It is a violation of Federal law to use this product in labeling.

B-1030-10 is used to inhibit fungal degradation of water-based and emulsifiable cutting fluids and cooling operations. It should be added at a rate that will provide 100 to 250 ppm B-1030-10 (weight/weight) with water. B-1030-10 can be added to the concentrate before dilution to prevent growth on the inside walls of the dilution fluid storage tanks, higher concentrations are needed. For this application it is recommended that B-1030-10 be diluted fluid as it is prepared to provide a concentration of 1000 to 1250 parts per million.

STORAGE & DISPOSAL
