DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with the labeling.

B-30-7 is used to inhibit fungal degradation of water-based and emulsifiable cutting fluids and cooling lubricating operations. It should be added to a rate that will provide 150 to 250 parts per million (weight/weight) of B-30-7 with water. B-30-7 can be added to the concentrate before dilution to prevent growth on the inside walls of the dilution fluid storage tanks, higher concentrations are needed. For this application it is recommended that B-30-7 be diluted to a concentration of 1000 to 1250 parts per million.
