

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

B-30-8 is used to control the fungal degradation of water-based emulsifiable cutting fluids and cooling operations. It should be added at a rate that will provide 150 to 250 ppm B-30-8 (weight/weight) with water. B-30-8 can be added to the concentrate before dilution to prevent growth on the inside walls of the fluid storage tanks, higher concentrations are needed. For this application it is recommended that B-30-8 be diluted fluid as it is prepared to a concentration of 1000 to 1250 parts per million.

STORAGE & DISPOSAL
