

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

B-30-9 is used to inhibit fungal degradation of water-based and emulsifiable cutting fluids and cooling operations. It should be added to a rate that will provide 150 to 250 parts per million of B-30-9 (weight/weight) with water. B-30-9 can be added to the concentrate before dilution. To prevent growth on the inside walls of the dilution fluid storage tanks, higher concentrations of B-30-9 are needed. For this application, it is recommended that B-30-9 be added to the diluted fluid as it is prepared to provide a concentration of 1000 to 1250 parts per million.
